Every spring and fall, a crop of soon-to-be lawyers crowd into court-rooms throughout the state, eager to take part in a ritual that most of us have tucked away deep in our memories. They raise their hand and pledge to uphold the words of the lawyer's oath, which towards the end, includes a powerful promise:

I will never reject...the cause of the defenseless or oppressed....

In today's economy, the need for lawyers who will answer that call could not be greater. According to a recent study by the Michigan League for Human Services:

- 6.8 percent of Michigan residents (and nearly one in every four children) lived in poverty in 2010—the highest rate since 1984;
- Foreclosures continue to plague Michigan families, with our state registering the third highest number of foreclosures nationally in October of 2011; and
- Michigan's unemployment rate led the nation for most of the last decade, ranking first from 2006-2009, and only second in 2010.

Meanwhile, the Michigan Bar Foundation reports that legal aid programs must turn away nearly *half* of those who seek their help due to a lack of resources.

So, as a young lawyer, what can you do to help?

If your firm has a pro bono program, get involved! Or, if such a partnership does not exist (or if you're a sole practitioner), consider reaching out to your local legal services organization to set one up. A list of such agencies is available here. The State Bar's Pro Bono Initiative is another great resource for innovative ideas.

I also encourage you to volunteer your time with the State Bar of Michigan Young Lawyers Section (YLS). One of our core missions is to provide service to the public, which we accomplish both through community service events and pro bono legal projects (like *Wills for Heroes* and seminars that are free and open to the public).

The event was organized to benefit SKIP, a local non-profit dedicated to working with children of incarcerated parents. With the assistance of their attorney-partners, SKIP students enthusiastically took the lead in the trial by playing roles as lawyers, judges, witnesses, and jury members.

The script, which was drafted by YLS Member and DTE attorney Antoinette Gilbert, was based on the hit Pixar Film Madagascar 2, and involved a dispute between Melman Giraffe and Moto Moto Hippo over the ownership of a large diamond. After hearing testimony and watching the witnesses endure blistering cross-examination by their fellow student-attorneys, the jury ultimately found for the defendants.

Afterwards, students engaged in a lively discussion with the attorneys about the practice of law, took a tour of the lock-up facilities, and enjoyed lunch and good conversation with the other participants. A good time was had by all.
