While attending the American Bar Association Young Lawyers Division Spring Conference in St. Louis, Missouri, I noticed a recurring theme in some of the programming—Michael Brown, the Ferguson riots, and protesters' rights. During the conference, I attended a session entitled "Beyond Free Speech: Understanding Protesters' Legal Rights." During this session, I received a crash course on the First Amendment rights of protesters. Additionally, I had the opportunity to hear, first hand, from a lieutenant from the St. Louis Police Department, who vividly described how law enforcement officers from the local area joined forces to control the situation in Ferguson. Continuing with the discussion on Ferguson, I attended a session entitled "What Happened in Ferguson and What Can Lawyers Do?"

This session included a panel that discussed what led to the social unrest in Ferguson, and communities like it. The panel included subject matter experts who were directly involved in drafting the Ferguson Commission report, entitled "Forward Through Ferguson: A Path Toward Racial Equality." Cover Letters for Practitioners

over letters were difficult to write in law school, but they are even more difficult to write as a practitioner, especially when you no longer have career services around the corner from your locker. So here are some basic tips which can help. The format for every cover letter is straightforward: in the first paragraph you should introduce yourself (but never say "my name is..."), state what job you are applying for, and why you are motivated to work for the employer or live in that geographic area. In the second, and maybe third paragraphs, you really try to persuade the employer that you are the ideal candidate, and state how you have successfully used the skills in the past that the employer has mentioned in the job description. You should also research the employer to find news and information about the company that might tell you why the employer might need to hire you. You can then talk about your skills that might relate to that area of need in your cover letter. In the third, or maybe fourth, paragraph summarize precisely why you are the perfect candidate, state what other documents you have enclosed or attached, and ask the employer for an interview. Your cover letter is an example to the employer of how you communicate, and as we all know, written communication is king in the practice of law, so it needs to be absolutely perfect so edit it like your future depends on it, which it does.



Imran Syed Assistant Clinical Professor of Law University of Michigan Law School Innocence Clinic Ann Arbor, MI

Imran Syed is an assistant clinical professor of law. He teaches in the Michigan Innocence Clinic, and also teaches a seminar on forensic science. Imran graduated from the University of Michigan with a degree in political science before going on to Michigan Law. While in law school, he worked for two years in the Innocence Clinic as a student attorney and, upon graduation, served as a clinical fellow and staff attorney in the clinic for three years. As part of teaching in the Innocence Clinic, Imran has supervised

students investigating and litigating a wide variety of cases, including several of the clinic's forensic science-based cases.

Having litigated several arson wrongful convictions that were based on outdated fire science, Imran has also coauthored (along with Innocence Clinic colleague Caitlin Plummer) articles discussing the novel litigation strategies needed to address wrongful convictions based on scientific evidence that is valid when used, but later comes to be repudiated.

Imran has spoken and written about a variety of topics related to wrongful convictions, such as compensation for exone rees, the fallacies of eyewitness testimony, and the need for reform in Michigan's system of public defense. In 2014, Professor Syed wrote and produced a documentary film, *The Price of Providence*, about one of the Innocence Clinic's wrongful conviction cases.
