# Opportunity for New Lawyers to Learn Basics of Misdemeanor Representation

In this tough job market, new lawyers have to broaden their skill set and look for new sources of income. New lawyers often seek criminal defense appointments at the district court level to get their feet wet. There are many daunting aspects to beginning a criminal defense practice, including how to get appointments, what procedures to follow, how to work with the district court prosecutor, and what to expect from the district court judge.

To help answer these questions, the Oakland County Bar Association (OCBA) is holding a continuing legal education seminar for new lawyers and lawyers new to criminal defense. The OCBA's Criminal Law and Municipal Law Committees are partnering to host *Misdemeanor Representation: From Appointment to Zealous Advocacy*. The seminar is on Wednesday, March 24, 2010, at noon.

This two-hour seminar will follow the process of a misdemeanor case. It begins with an explanation of how to get appointment work at the circuit court level. Angelina Sharon of the Oakland County Circuit Court Administrator's Office will review the requirements to be appointed to the circuit court. Each Oakland County district court sets its own requirements for appointment work. An overview of the common requirements and pay rates of the district courts will be presented by State Bar of Michigan Young Lawyers Section council member and OCBA New Lawyers council Director Syeda Davidson.

Veteran defense attorney and chair of the OCBA Criminal Law Committee Ray Correll will present on what happens beginning with the appointment and will provide insight to help new attorneys guide their way through the court process.

Experienced municipal prosecutors Vahan Vanerian and Hans Rentrop will discuss the role of the prosecutor in misdemeanor matters. Vahan and Garret will discuss the process of negotiating with defense counsel, particularly, what impacts the decisions they make on pleas and what amount of discretion they may exercise. Both prosecutors will offer tips for providing a criminal defendant with the most effective representation, and what tactics should be avoided.

Respected jurist and active bar member Hon. Cynthia Walker, of the 50<sup>th</sup> District Court in Pontiac, will present a judge's role in misdemeanor matters. Judge Walker will provide expertise on sentencing guidelines, alternative sentencing options, and plea deals. She will also give her insights into the best and worst practices that she sees in her courtroom.

A question-and-answer period will be open to the audience and moderated by OCBA Municipal Law Committee Chair Kristin Kolb following the substantive presentation.

This seminar is open to anyone. It is from noon to 2 p.m. on Wednesday, March 24, 2010, in the CLE room at the OCBA's offices at 1760 S. Telegraph Road in Bloomfield Hills. Because this seminar is for new practitioners, the price has been reduced to only \$40 for OCBA members and \$55 for non-members who pre-register. # What I Wish I Knew

**H**aving practiced law for 15 years (and after officially entering “middle age”), there are a few things I wish I had known when I was a young lawyer:

1. **Think About It.** Take the time to reflect on what you want from your career. Find a mentor or a career coach, someone you trust to help you make the most of your career. Going through life without taking the time to understand where you’re going will lead to nowhere. Moving from one job to the next or changing practice areas based on the belief that someone else has designed the perfect job for you is crazy. Know what you want from your life—know your highest values—and create your own perfect job.
2. **Focus.** If you focus exclusively on the details of your life, you’ll lose the Big Picture. It’s easy to spend countless hours fretting about minutiae instead of considering what’s truly important. Of course, details must be handled. But if you never ask life’s big questions, you’re likely to find yourself filling in details rather than living the life you once imagined.
3. **Trust Yourself.** Conventional wisdom tells you to “grind it out” for 40 years, and when you finally retire you can do what you’ve always wanted. Talk about delayed gratification! If you learn to love your job now, every day will feel like retirement. Many lawyers love what they do. Be one of those lawyers.
4. **Move Backwards to Go Forward.** Sometimes you must take a step backwards to move two steps forward. It’s much easier to make life changes as a young lawyer than to make them after you’re married with two kids and a mortgage on top of your student loans. If you have any doubts about your career, take the time *now* to consider what you truly want. It will never be any easier for you to make changes than it is right now.
5. **Be Grateful.** Who you are is much more important than what you do. Most of us get so caught up in “doing” that we forget to enjoy the ride. Life is a series of experiences, and even if you’re in the middle of some pretty stressful stuff, being grateful and making the most of difficult situations makes all the difference.
